Even though few faults and violence being focused to light while others resting in peace, more than 80% of women living in northern part of India like Uttar Pradesh, Bihar etc., are endangered to all of these crime rates in general and women abuses in particular have increased substantially. Women over these areas are not well educated and unaware of things which pave a green signal to all red zoned crimes.

Rural women help men, but men instead, harass them and also even they are baffled up by their owners for even small faults and treated as slaves in stone quarries. Some of the educated girls are not even assured of their own safety as transportation facilities are scarcely available to them and majority of girls even now don't get proper education because of lack of safety. The brutality of the assault stunned the whole of India and the press dubbed her, Nirbhaya - the fearless one. The term weaker sex does not fit in this box, rather "women survivors" suits well. Valorous men are not strong either, surviving women are real warriors.

Humiliations chase the survivors- Agartala, the capital of Tripura where the 17 years old girl was held captive and allegedly raped for days by her boyfriend and his friends, and also they set her on fire where she was rescued with 90% of injuries by the local police. Humiliations chase the survivors throughout their life, some women stand to fight against like her and some spend their life on ventilators or they are burnt alive.

Sexual violence in rural part of India- Rape and sexual violence against women have been in multiple numbers in India in recent years. Some tragic incidents include Indian veterinarian woman doctor of 27 years was allegedly raped and murdered in Hyderabad on November 29, 2019, A 16 year old teenager being sexually abused by her own father at home with willing consent from her mother for around two years in rural place called Kasaragod in Kerala district. A case

was filed in Sirumugai, in the Coimbatore district on a victim's father for his sexual torture on his own daughter.

The valley gaze its own crop- On 2nd June 2020, Odisha cop held for raping 13-year-old-girl repeatedly at Odisha's Birmitrapur police station. Police being the guardian angels for protecting people stain our body with blood. It seems like "the valley gaze its own crop". Many girls and other women feel safe to move around other country rather to move with fear in their mother land. Even animals are far more superior to these brutal rapists. If we can coexist with animals we will benefit far more. After commitments of heinous crimes how can still men pass lewd comments about women? III. INDIA'S EFFORTS
